

## Subject | COMMUNICATION OF CHARGES FOR SPECIAL USE OF PORT FACILITIES AND AIDS TO NAVIGATION IN THE PORT AUTHORITY OF VALENCIA IN FORCE AS FROM 1 JANUARY 2026.

We hereby inform the relevant parties that the rates for special use of port facilities and aids to navigation, as well as the allowances for application of the provisions of article 245.3 and 245.4 of the Consolidated Text of the Law on State Ports and the Merchant Navy that have come into force as of 1 January 2023, are those listed below in the summary section on modifications. This is because of the following:

1. Consolidated Text of the State Ports and Merchant Navy Act (hereinafter TRLPEMM), approved by Royal Legislative Decree 2/2011 of 5 September (BOE No. 253 de 20/10/2011).
2. Agreement of the Board of Directors of the Port Authority of Valencia in session held on 16 December 2022.
3. Law 31/2022, of 23 December, of the General State Budget for the year 2023 (B.O.E. No. 308 of 24 December 2022).
4. Article 134.4 of the Constitution, according to which "if the Budget Law is not approved before the first day of the corresponding financial year, the Budgets for the year shall be considered automatically extended until the approval of the new ones".

### MODIFICATIONS REGARDING PORT FEES AND TRADE BONUSES:

- For the year 2026, the corrective coefficients for the rates of the ship, passenger and merchandise are maintained, as well as those applicable to the basic amounts R1 and R2 for the provision of the service for receiving waste generated by ships as set out in article 132. of the Consolidated Text of the Law on State Ports and the Merchant Navy. <sup>(1)</sup>
- Regarding bonuses, those approved for fiscal year 2023 are maintained. <sup>(1)</sup>

### REMARKS

1. At the end of this communication we include an annex that includes all the bonuses that are applicable during the current financial year <sup>(1)</sup>. It explains in detail the conditions of their application.
2. We remind the relevant parties that, at the Electronic Headquarters of the Port Authority of Valencia, the following procedures are available in relation to the rebates set out in articles 245.3 and

- PA-3214 Provisional application of the allowances of Article 245.3 of the TRLPEMM, for the application in the settlements of the allowances included in this article, on account of the regularisation at the end of the financial year.
- PA-321X Provisional application of the rebates of article 245.4 TRLPEMM, to apply for the rebate accrued each quarter by the provisional application of the rebates of art.245.4.
- PA-3215 Annual regularisation of rebates articles 245.3 and 245.4 TRLPEMM, to be presented at the end of the financial year, in order to regularise those provisionally applied during the year.

**C.** Vessels and recreational or sporting craft of less than 9 metres in length if propulsion is by engine:

**C1.**  $(\text{€}0.29 + \text{€}0.28) \times \text{length} \times \text{beam} \times 40$  (one-time, indefinite validity).

**C2.** When not based in a Spanish port:  $[[[(\text{€}0.29 + \text{€}0.28) \times \text{length} \times \text{breadth} \times 40] / \text{number of days in the year}] \times \text{days in port}]$ .

**Basic rate:** short sea shipping = €1.20 other sea transport = €1.43

**Corrector coefficient:** 0.90

**Calculation of the charge:** GT/100 X hours of stay to be settled X the following sums (including the basic sum, corrector coefficient and charge coefficients):

(In the case of prolonged use of mooring or anchoring facilities, the stay will be measured for periods of 24 hours or fraction thereof and with the conditions of stay set out in art.197 of the Consolidated Text of the Law on State Ports and the Merchant Navy, approved by Royal Legislative Decree 2/2011, of 5 September).

**C. Incoming or outgoing cargo and transport elements by maritime route transported on vessels integrated into regular short-distance maritime services:**

2. Where goods are loaded or unloaded by roll-on/roll-off in ro-ro or similar vessels: the coefficient shall be 0.6 of the values in section A.

**D. For cargo and transport elements entering or dispatched from the service are of the port by rail:**

A coefficient of 0.50 shall be applied to the values in section A.

**The above sums of the charges shall be subject to the rebates approved by the Port Authority of Valencia, (annex to this communication), published in Law 31/2022 of the General State Budget for 2023.**
