RESOLUTION OF THE GENERAL MANAGER

Considering the Economic Report of the Head of Port and Commercial Services to update tariffs for the mooring and unmooring service in the Port of Sagunto for 2026 (SVC) “hhXh G3eL QfUT oLfF KYGS pBJs uQE=”, the Report by the Head of Operations to the Port Services Committee proposing the update of maximum tariffs for the mooring and unmooring service in the Port of Sagunto for 2026 (SVC) “abxJ NeIn KwKQ TspX WZyk +kcv les=” and, having consulted the Committee on 14 January 2026 with no allegations, this Directorate General, using the delegation by the Board of Directors in a Resolution dated 29 February 2024 (reference 2.4.1.), (Official State Gazette-BOE no. 57 of 5 March 2024).

HAS RESOLVED:

ONE. - To approve the maximum tariffs for the mooring and unmooring service in the Port of Sagunto for 2026, attached to this Resolution as Annex I, which represent an increase of **2.192%** over the current tariffs. The update will take effect on **15 January 2026, with T0 being the tariff to be applied** based on the cumulative tonnage during 2025.

TWO. - To approve tariffs for intervention in emergency situations, rescue operations, firefighting or pollution control for 2026, attached to this Resolution as Annex II, which represent an increase of **2.192%** over the current tariffs. The update will be effective on **15 January 2026**.

THREE. - To order the publication of this Resolution and its annexes on the Port Authority of Valencia website for general information.

- b) An amendment on the same quay of less than three bollards or approximately 60 metres shall be charged at 50% of the rate applicable to a mooring operation. All other amendments will be charged as a mooring operation.
- c) Mooring and unmooring operations at the quay corresponding to the regasification plant SAGGAS, SA will be subject to a surcharge of 80% of the base rate, including the use of auxiliary vessels.
- d) The maximum tariff for using a vessel, if applicable, is T(€) = €116.50 per service. The applicable tariff for the use of a tender shall be charged together with the fee for the mooring service.



ANNEX II

Tariffs for intervening in emergency situations, conducting rescue operations, firefighting or pollution control

- a) For firefighting interventions, for each vessel assigned to the service and its corresponding crew, €786.24/hour.
- b) For firefighting interventions, for each off-road vehicle assigned to the service and two line handlers, €173.29/hour.
- c) For pollution control, rescue or emergency interventions, for each vessel assigned to the service and its corresponding crew, €786.24/hour.
- d) For pollution control, rescue or emergency interventions, for each off-road vehicle assigned to the service and two line handlers, €173.20/hour.
- e) For interventions by additional line handlers, €69.07/hour.
- f) For interventions with specific cleaning vessels and their corresponding crew, €602.22/hour.
