### RESOLUTION OF THE GENERAL MANAGER

Considering the Economic Report of the Head of Port and Commercial Services to update tariffs for the port towage service in the ports of Valencia, Sagunto and Gandia for 2026 (SVC) "8v78 jMKK ZIZG DylF gVWU U1IN 3Kc=", the Report by the Head of Operations to the Port Services Committee proposing the update of maximum tariffs for the mooring and unmooring service in the Port of Valencia for 2026 (SVC) "uTG8 ZiNW weAZ q6sV 0J4q lpw0 kv0=" and, having consulted the Committee on 14 January 2026 with no allegations, this Directorate General, using the delegation by the Board of Directors in a Resolution dated 29 February 2024 (reference 2.4.1.), (Official State Gazette-BOE no. 57 of 5 March 2024).

#### HAS RESOLVED:

**ONE.** - To approve the maximum rates for the port towage service in the ports of Valencia, Sagunto and Gandia for 2026, attached to this Resolution as Annex I, which represent an increase of **1.372 %** over the current tariffs. The update will take effect on **15 January 2026**, with **T0 being the tariff to be applied** based on the cumulative tonnage during 2025.

**TWO.** - To approve tariffs for intervention in emergency situations, rescue operations, firefighting or pollution control for 2026, attached to this Resolution as Annex II, which represent an increase of **1.372%** over the current tariffs. The update will be effective on **15 January 2026**.

**THREE.** - To order the publication of this Resolution and its annexes on the Port Authority of Valencia website for general information.

1. The tariffs applicable to towage services shall differentiate between the following operations: entry manoeuvres, exit manoeuvres and changes of quay.
2. For operations for ships without engines, for operations in dry dock, if any, and for changes of quay, the surcharge to the base amount shall be 50%.
3. Services provided other than entry or exit manoeuvres or changes of quay, including stand-by services, shall be invoiced at a maximum rate of €1,115.09/hour/tug.
4. These maximum tariffs will be applicable when the number of service providers is limited or insufficient to guarantee competition, once approved by the APVLC Board of Directors in accordance with the provisions of Article 125.2.d) of the TRLPEMM.



## **ANNEX II**

### **Tariffs for intervening in emergency situations, conducting rescue operations, firefighting or pollution control**

- a) For firefighting service interventions, for each tug and its crew €4,054.87/hour.
- b) For pollution response intervention, for each tug and its crew €1,013.72/hour.
